**LOCAL LAW # 2 of 2004 of Town of Westville:  
CHANGING THE TERM OF OFFICE OF ALL ELECTIVE OFFICES  
FROM  
TWO (2) YEARS TO FOUR (4) YEARS.**

**Section 1. Purpose**

To change the Term of Office of all elective offices from two (2) years to four (4) years.

**Section 2. Term of Office**

It is hereby enacted by the Town of Westville that the Term of Office of all elective offices for the Town of Westville shall be four (4) years.

**Section 3. Effective Date**

This Local Law is subject to a mandatory referendum at the next general election on November 2<sup>nd</sup>, 2004 and shall be effective upon approval by a majority of the voters voting in such election. If approved it shall be effective for any officers elected at such general election and any elected thereafter.
