Amendment to Local Law #2 of 2002 --- Dog Control Law

Replace Section 6 LICENSING FEES AND THEIR DISPOSTIONS

As authorized by Section 110 of the A.M.L. and as required for controlling dogs, the fee for licensing dogs will be in accordance with any Local Law, Ordinances, Rules and Regulations in affect during the life of this Local Law. The Local Fee's are as follows; for spade and neutered dogs \$10.00, for non-spade and non-neutered dogs \$25.00, for Pure-Breed dogs 1-10 the fee is \$15.00 and for 11-25 dogs the fee is \$25.00. Theses prices include tags.

Add Section 20 PENALTIES AND FEES FOR LOCAL LAW

The fee's are as follows: within a 12 month period from first offense:

First offense: \$20.00
Second offense: \$40.00
Third offense: \$80.00
