This undertaking of the Town Justice is further conditioned that he will well and truly keep, pay over and account for all moneys and property coming into his hands as such Justice; and

The Town does and shall maintain insurance coverage, presently with NYMIR Insurance Company, in the sum of \$ 300,000.00, includes for the Town Supervisor, Town Clerk, Town Justice and the Receiver of Taxes to indemnify against losses through failure of the officers, clerks and employees covered thereunder faithfully to perform their duties or to account properly for all monies or property received by virtue of their positions or employment, through fraudulent or dishonest acts committed by the officers, clerk and employees covered thereunder.
